

## Annual General Meeting Elections

Council consists of the Chair and the other Honorary Officers together with as many additional Trustee Directors as will bring the total up to sixteen persons. All Trustee Directors (including the Chair and the other Honorary Officers) are elected for a three-year term.

Under the Articles of Association, persons who wish to stand for election must be a member of the Synagogue. Additionally, the Charity Commission require all those standing to make a declaration.

Persons wishing to stand must complete the declaration and be nominated by two other members of the Synagogue. The deadline for receipt of nomination is **Wednesday 1 December**. Candidates are also invited to prepare a short personal statement for distribution.
